For PSH, our community prioritizes those with the most severe medical, mental health, behavioral health, or substance use conditions and who have been living on the streets or emergency shelters the longest.

Homes for New Beginnings

- For individuals only, no couples/families
- Must meet HUD's definition of Chronic homelessness
- Must have current SSI/SSDI Income
- Must have ID, Social, proof of income
- No sexual offenses/murder charges. No drug sales/manufacturing or violent felonies in last 3 years
- Single Site housing located at 4049 S. OBT in own efficiency unit. On site CM. (Maxwell Gardens)

Safe Haven

- For individuals only, no couples/families
- Must meet HUD's definition of Chronic homelessness
- Must have ID, Social, proof of income
- No sexual offenses/murder charges. No drug sales/manufacturing or violent felonies in last 3 years
- Single Site housing located at 4049 S OBT in own dorm-style unit. Private room, shared bathrooms, living room, kitchen. On Site CM. (Maxwell Gardens)

Restore 1 & 2

- For individuals only, no couples/families
- Must meet HUD's definition of Chronic homelessness
- Restore 1 homelessness within our CoC
- Restore 2 homelessness must be within Orange
- Must have ID, Social, proof of income
- No sexual offenses or murder charges. No drug sales/manufacturing or violent felonies in last 3 years
- Single Site housing located at 3200 W Colonial in own efficiency unit. On site CM. (Maxwell Terrace)

Step Up at Warley Park

- For individuals or households
- Must meet HUD's definition of Chronic homelessness in Seminole
- Must have ID, Social, proof of income
- No sexual offenses. No violent felonies in the last 3 years
- Single Site Housing located at 1500 W 25st Sanford in own unit. On site CM.

Pathways to Home - Embrace Families

- Families only, must have minors
- Household size must be eligible for a 3 bedroom
- Must meet HUD's definition of Chronic homelessness
- Must have ID, Social, proof of income
- Case by case w/ Drug/violent criminal/sexual offenses
- Single site housing located in Seminole in own unit

- Must have documented SMI (severe mental illness)
- Must have ID, Social, proof of income
- No sexual offenses
- Scattered site housing in Osceola in own unit

Shelter + Care Seminole

- For individuals or households
- Must meet HUD's definition of Chronic homelessness in Seminole County
- Must have ID, Social, proof of income
- No sexual offenses
- Scattered site housing in Seminole in own unit

Shelter + Care Orange

- For individuals or households
- Must meet HUD's definition of Chronic homelessness in Orange County
- Must have ID, Social, proof of income
- No sexual offenses
- Scattered site housing in Orange in own unit

Christian Service Center

- For individuals or households residing in Orange
- Must meet HUD's definition of Chronic homelessness (or long term homeless if from city of Orlando)
- Must have proof of income. Flexible with a valid ID and proof of social.
- Scattered site housing in tri-county in own unit.

HCCH

- · For individuals or households
- Must meet HUD's definition of Chronic homelessness (or long term homeless if from city of Orlando)
- Must have proof of income. Flexible with a valid ID and proof of social.
- Sexual offenses may limit case management assignment
- Scattered site housing in tri-county in own unit.

Pathway Homes

- · For individuals or households
- Must meet HUD's definition of Chronic homelessness (or long term homeless if from city of Orlando)
- Must have proof of income. Flexible with a valid ID and proof of social.
- Sexual offenses may limit case management assignment
- Scattered site housing in tri-county in own unit.

Aspire Seminole

- · For individuals or households
- Must meet HUD's definition of Chronic homelessness in Seminole County
- Must have proof of income. Flexible with a valid ID and proof of social.
- Sexual offenses may limit case management assignment.
- Scattered site housing in tri county in own unit

Miracle of Love

- For individuals or households
- Chronic homelessness, but flexible with history (doesn't have to meet HUD's exact definition)
- Must have documented proof of HIV/AIDS
- Must have ID, Social, proof of income
- No sexual offenses
- Scattered site housing in tri-county in own unit.

Single Site: Participants live at a single complex where Case Management services are provided by on-site staff. Must first pass leasing application with Property Manager before being able to enroll with the program.

Scattered Site: Participants live in a unit in the community and Case Management services come to them in their home.

All PSH Programs require the following:

- Work directly and regularly with a Case Manager
- · Home visits at least monthly, more frequently when housing or safety are at risk
- Contribution towards rent (30% of participant income goes towards rent and utilities)
- Work towards goals that will help the participant maintain housing stability and increase independence
- Abide by lease and program rules
